Our services

Domiciliation services

One of the basic needs of our client companies is being registered in the country of residence.

ATC provides a registered office address at its own offices. This address is then used as the official registered office address and correspondence address, where for instance the corporate records are maintained and management board meetings may be held. In addition to fulfilling basic needs, ATC can also provide separate phone and fax lines, e-mail addresses and the lease of separate office space.

Management services

In many cases our client companies require directors who are inhabitants of the country of residence of the client company. The management services provided by ATC include acting as local director either as a corporate managing director (i.e. through a legal entity) or ATC can provide one or more individuals. It is common practice that ATC acts as managing director alongside representatives of the client on the board of managing directors of the client entity. The articles of association of the client company

then stipulate that the board of managing directors consists of a managing director A and a managing director B who, acting jointly, are authorised to represent the company.

Administrative services

ATC provides and co-ordinates all financial administration in accordance with the applicable legal requirements. On request our administrative services include day-to-day bookkeeping, monthly, quarterly or semi-annual reporting (bank reporting, trial balance sheet reporting, full financial reporting). ATC is accustomed to working with all major accounting software and has substantial experience in reporting packages. We can arrange banking services with the leading local bank of the client's choice.

Legal compliance

Our in-house corporate lawyers are available to ensure that the client company fulfils its obligations under the relevant law/s and to take care of the local corporate housekeeping, such as drafting the necessary board and shareholders' resolutions, and filing documents with the relevant local authorities. Incorporation / Acquisition of a shelf company

Our legal staff assist our clients with the incorporation of new local entities and with the sale and transfer of shelf companies. ATC offers a wider range of shelf companies in order to meet the specific demands of the client. The bank account required for the incorporation of a new company can be arranged within 72 hours, subject to certain requirements.

Private equity

We have many years of experience in supporting private equity firms, from start-ups to well established names, in the set up, implementation and operations of investment structures, including fund, management, co-management and special purpose vehicles.



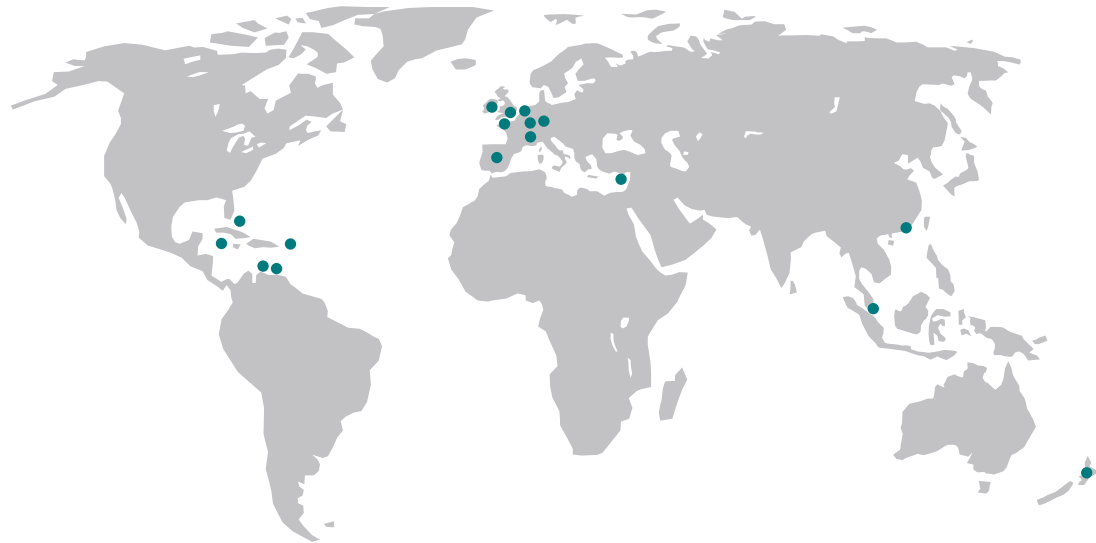
